




LCDR USN Retired.

The latest episode of the *Queen Mary* collision in 1942 involves Jake Hendrix and myself. In June of this year the Canadian company Northern Sky Entertainment called me about going to Long Beach, California to the *Queen Mary* where a documentary is to be started concerning ocean disasters. As an eyewitness to the wreck and taker of the photograph of the wrecked half of the H.M.S. Curacao they wanted to do an interview and any constructive information we could add. I furnished a short list of several of the fellas that I knew were on the *Queen Mary* and consequently they invited Jake to participate.

The producing company had hired a group of 'enactors' dressed in O.D. uniforms of various WWII combinations. One morning was spent interviewing Jake on the deck at the spot he was standing when the collision occurred. The next morning they did the same with me at my spot on the deck where I took the picture. Later, we watched them enacting the scenes where G.I.'s ran from one side to the other to try to see the front half of the *Curacao*. The producer (director?) did ask our opinions on several occasions what we thought of the accuracy of the acting. They even had a young, very tall man acting my part at the time of the wreck, even using the original Kodak 620 camera-which, by the way, Jake borrowed from the March Field Museum. My family and I stayed another few days on the *Queen*, now a hotel, before flying home.

An English partner in this production later contacted me to see if I would go to Belfast, Northern Ireland to participate in some further filming there. Of course I was available to make the trip. My daughter, Nancy, went with me. We left Tulsa July 8th and returned July 15th.

The reason to do the filming in Belfast was an old British warship, the *H.M.S. Caroline*, permanently docked there and is fairly close to the size and shape of the *Curacao*. The company had to get special permission from the British government to use the ship because it is still carried on the navy 'roll' and is used for Naval Reserve training, etc..

Two survivors were located and they were there to be interviewed. This location had enactors in British Navy uniforms running and jumping (on thick mattresses on the deck) through the smoke from a smoke machine imitating jumping from the sinking *Curacao*. The two British sailor survivors, aged 85 and 83 were very alert and active and a delight to visit with. I gave each of them an enlarged picture of the wreck, which they had not seen before. After the filming was over the local T.V. station interviewed the two survivors and myself and put us on their 5:30pm news. The local people we talked to were very friendly and interested in the story of the *Queen Mary* collision.


After my involvement in the filming was over, Nancy and I stayed another four days to see more of Northern Ireland. We took a 100-mile train trip to Londonderry/Derry to try to locate our camp location at the village of Eglinton, just outside of Londonderry/Derry. The town and countryside had changed too much to find our campsite but did locate the very old church I took a picture of in 1942. It was quite interesting in comparing that picture with the present day church.

The documentary is to be finished by the end of this year and is already sold to National Geographic. No one knew at the time of the filming when it would be shown on National Geographic T.V. but I have been promised that I would be informed in time to catch it on T.V., sometime after the first of the year.

I plan to bring some pictures of the Irish trip to the reunion that Nancy had put on DVD.

Hope to see you all in Cincy.




"Sidewalk Repast" in Belfast ,North Ireland

Hello Everyone,

The overall grand total of worldwide visitors to the 82nd FG website through the end of July totaled: 390,557. We had a couple of slower months, in the late spring. But, the visitor numbers are now back, to the higher numbers.

The Cincinnati Reunion is fast approaching, Oct. 1st - 4th. A reminder to everyone to call the Holiday Inn Cincinnati Airport to make their hotel reservations, as soon as possible, to get the Reunion rate. Also, to fill out the enclosed Reunion registration form and mail it. All this information is needed, so, we can start to finalize the Reunion plans.

We want to make sure that all 82nd FG family members know that, they are most welcome to attend the 82nd FG Reunions. This year's Cincinnati Reunion business meeting will be a very important and historic meeting. If all goes well, the original 82nd FG members will vote to amend the By-Laws, to make the descending generations of the 82nd FG members, Full Members of the 82nd FG Assn.

The amended changes to the By-Laws will help preserve and secure all of the brave and historic accomplishments of the 82nd Fighter Group, through the future generations of family members.

A new documentary about the October 1, 1942, collision of the Queen Mary and the H.M.S. Curacao is in production. It is scheduled to be released in 2009. Olen Medley and Jake Hendrix were present on the Queen Mary in Long Beach this past June for some of the filming.

In July, Olen was also in Belfast, Ireland for additional filming, which also included survivors of the H.M.S. Curacao.

The wreckage of the H.M.S. Curacao was found last October. They are diving on it again this summer and filming it this time. The German U-Boat, U-407, did fire torpedoes at the Queen Mary.

In the Spring NEWSLETTER, you may remember the picture of 'CE' on Salerno. Al Schneider / 97th contacted me. He was very excited about that photo and remembered the day very well. Needless to say, Al told me the exciting story.

Recently, I received a communication from our fellow researchers in Italy. They have located a crash site that revealed human remains. The crash site is located in the area of where Maj. Hugh Muse / 95th went down on 12/25/43. They thought it might have been Maj. Muse. Checking our records of all the pilots and planes the 82nd FG lost on 12/25/43, all have been accounted for, except for one, 2nd Lt. Robert M. Croddy / 95th - MIA.

I immediately notified the MIA/POW division at the Pentagon. They will be officially involved in the crash site excavation and recovery now.

Major Andy Klein/97th FTS/ Lightning II, talk at least once a month. He informed me that Lightning II - B flew in May for the first time. It was just regular test flying. No vertical take off procedures yet. Lightning II - C is scheduled to fly next year.


