

Dear Hank.

As I was asked to do by my late father, I am writing to inform you that William Harold Burgess passed away last week on December 30<sup>th</sup>. He was eighty-six years old when he died. His sudden and unexpected passing was a shock to everyone in his family and to everyone that knew him.

Dad was a member of the 82<sup>nd</sup> Fighter Group for a good part of his life. He flew P-38's while stationed in Europe during World War II. After leaving the Air Force Captain Burgess flew for American Airlines from 1953 until his retirement in 1982. He loved flying and was always grateful that he was given the opportunity and talent to be able to do so. All the time that he was flying for American, and even after his retirement, he always told me that "he didn't think anyone in the world had a better job than he did." He truly loved what he did.

A Memorial Mass will be held for dad on Friday, January 23<sup>rd</sup> at the St. Jude Catholic Church in Tequesta, FL at 11:00 a.m. He will be buried at the Calverton National Cemetery in Calverton, NY with, as he put it, some of my old WWII buddies. If you would be kind enough to pass along his passing in your various publications so that the remaining "Grey Eagles" and P-38 and 82<sup>nd</sup> Fighter Group guys will know of it. Here is a brief summary of the, amended and new verbiage, of these specific By-Laws:



# Remembering the Life of Irving Mamen Swenson



Irving Mamen Swenson, known as "Swede", was born September 25, 1920 in Minneapolis, MN to Arthur and Evelyn (Mamen) Swenson. He later moved to Holland, MI where he was raised and educated. Irving was united in marriage to Margaret Wall, July 11, 1942. He served with the U. S. Army Air Corps during WW II and with the U. S. Air Force during the Korean Conflict. Following his discharge, he was an air traffic controller in Detroit, MI and later was employed as a private corporate pilot for a number of companies including Whirlpool, Schultz & Lindsay Construction and ConAgra. Irving had the distinction of being the

first pilot to land a Lear Jet at Hector International Airport in Fargo. Following his retirement, he built a home on Rose Lake near Vergas, MN. Margaret died in 1993. Irving was united in marriage to Darlene Andresen, March 26, 1994 in Detroit Lakes. They lived near Rose Lake, in Naples, FL and in Perham, MN, prior to moving to Detroit Lakes.

Irving was a member of Zion Lutheran Church, Jess-Omundson Post 1676, Veterans Of Foreign Wars in Detroit Lakes. He loved to fly and also enjoyed golf, and living on the lake.

Irving M. Swenson, 88, Detroit Lakes, MN died Friday, February 13, 2009 at Diamond Willow Assisted Living under the care of Hospice of the Red River Valley.
